Dear Ms. Hack,

As a proud employee of Community Wireless Communications, data provider for Lawrence Freenet, I would like to ask for your support of the Freenet-Kids proposal that will be discussed this Tuesday.

As an IT professional under the age of 30, I can attest first-hand to the impact the Internet has had on education and the younger generations. I grew up in a very small town in rural Kansas where we didn't have Internet at home or at my elementary school. By 6<sup>th</sup> grade I only had a vague idea of what the Internet was, but our district was adapting quickly. By my 8<sup>th</sup> grade year, our rural 2A school district partnered with four others to create a communications network over which we could share educational resources such as online encyclopedias and interactive classroom video feeds. By the time I was a sophomore, our newly built high school housed all of the 56k modems that the small town of about 1,500 used to connect to the Internet, as well as the closed circuit television channel used by the city to broadcast pertinent community information. In working with these new tools my interest in technology and the Internet began to grow and I started working with the school's technology department as a student aid. By my senior year, I applied and was accepted to Kansas State to pursue a degree in Computer Science. Now, after being in the software industry for the past 4 years, I find the Internet to be the most valuable tool in my profession and continuing education.

Looking back at those initial five years of education, from first signing in to a "chat room", to realizing that I could actually earn a living in Cyberspace, I sometimes wonder where I would be today if the school board and the administration had not had the vision, if the teachers had not had the encouragement and instruction, or if the community had not shown their support in passing the bond issue it took to turn mere ideas into fruition. Had I not had the privilege of access to technologies that I now use every day, how would my life be different? What opportunities would I have missed? What direction would I have taken instead? When thinking about it I realize how much credit should be given to all of those who saw the importance of opportunity for young students, and worked to make those opportunities available.

I know that it is not an easy task to keep up with the pace of technology, which is growing in sophistication and usage on an exponential scale. Anyone who can remember Commodore 64 or cell phones that came in a bag has some idea of this accelerated growth. But just to put it into some perspective, take this: In the 1980's, over a two year period, Internet usage jumped from 20,000 to 80,000 users. A decade later, over another two year period, usage jumped from 20 million to 80 million. Move ahead another decade to 2007 and in North America alone there are over 237 million users online. Evidence suggests this exponential rate of growth will most likely continue in the foreseeable future.

Unfortunately, this means that, unless preventive measures are taken, the digital divide will continue to grow at a comparable rate. Despite the vast increases in usage, it would be naïve for us to believe that access is equal for all. Indeed the more that the Internet

becomes a vital role in our everyday lives, the more important it is for us to see that everyone is staying educated and savvy. That is why it is better to act sooner than later to build bridges across the digital divide. With your support of the Freenet-Kids project, you will be investing in the future of our community by allowing the next generation of Lawrencians to better realize their full potential. In granting *every child* free access to the resources they need to excel in the classroom, Freenet-Kids is aimed at ensuring a resource rich environment in which all Lawrence kids can develop, while simultaneously allowing them to freely exercise and familiarize themselves with new technologies and possibilities.

We at CWC and LFN recognize that cooperation from the city commission has played a vital role in our current and ongoing success; a cooperation for which we are thankful and appreciative. We also recognize that this cooperation, the collective ambition of our dedicated staff, and the vision shared by the company and its members, can together turn the Freenet-Kids proposal into a magnificent victory for the city of Lawrence, and for its future generations, on whose innovations and leadership we will all one day rely as we move further ahead into the 21<sup>st</sup> century. Please join us in setting this precedent.



I feel the goal of Lawrence Freenet to provide Universal Internet access is a wonderful thing. As a father of two with my third child on the way I believe the Freenet Kids project is a great idea. As schools are continually integrating the internet into their curriculums for turning in homework, checking grades, correspondence, announcements, and news, the availability of the internet to our students becomes paramount. However, with the internet comes a great danger as well. Just today I was reading in the Journal World about a man who attempted to meet a 13 year old girl. As a parent I want to protect my children from these dangers. Fortunately as an IT professional I have a base of knowledge and skills to work from, but that is not the case for the average parent. Most parents know less about their computers than their children do. As that is the case, it is increasingly important that parents have the assistance they need in insuring a safe internet experience for their children.

It is a relief for me to know that companies like Lawrence Freenet are working hard to make safe access to this information available for all children in our community. Thus far, the city has had little expense in supporting the initiatives of Lawrence Freenet. Keeping in that tradition, their Freenet Kids proposal being revenue neutral once again allows them to do great things without asking the taxpayers to make it a reality. I encourage you to support the Lawrence Freenet initiative.


Dear City Commissioners,


To the Lawrence City Commission,
