ORDINANCE NO. 8304

AN ORDINANCE PERTAINING TO PROTECTION STANDARDS FOR ENVIRONMENTALLY SENSITIVE AREAS; AMENDING CHAPTER 20, ARTICLE 7, SECTIONS 20-701 AND 20-702; CHAPTER 20, ARTICLE 11, SECTION 20-1101; CHAPTER 20, ARTICLE 17, SECTION 1701; AND ENACTING CHAPTER 20, ARTICLE 11, SECTION 20-1109, BY INCORPORATING BY REFERENCE THE "DEVELOPMENT CODE OF THE CITY OF LAWRENCE, KANSAS, PROTECTION STANDARDS FOR ENVIRONMENTALLY SENSITIVE AREAS TEXT AMENDMENTS TA-12-27-07, JANUARY 27, 2009 EDITION" PREPARED BY THE LAWRENCE-DOUGLAS COUNTY METROPOLITAN PLANNING OFFICE, AND REPEALING THE EXISTING SECTIONS

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LAWRENCE, KANSAS:

SECTION I. The Governing Body of the City of Lawrence, Kansas hereby finds that the statutory provisions for the adoption of Development Code text amendments have been complied with, in consideration and adoption of the "Development Code of the City of Lawrence, Kansas Protection Standards for Environmentally Sensitive Areas Text Amendments TA-12-27-07, January 27, 2009 Edition" and said text amendments are hereby adopted.

SECTION II. Chapter 20 of the Code of the City of Lawrence, Kansas, 2008 Edition, and amendments thereto, is hereby amended to read as follows:

DEVELOPMENT CODE OF THE CITY OF LAWRENCE, KANSAS, PROTECTION STANDARDS FOR ENVIRONMENTALLY SENSITIVE AREAS TEXT AMENDMENTS TA-12-27-07, OCTOBER 28, 2008 EDITION

The "Development Code of the City of Lawrence, Kansas Protection Standards for Environmentally Sensitive Areas TA-12-27-07, January 27, 2009 Edition" prepared compiled. published and promulgated by the Lawrence-Douglas County Metropolitan Planning Office is hereby adopted and incorporated by reference as if fully set forth herein, and shall be known as the "Development Code of the City of Lawrence, Kansas Protection Standards for Environmentally Sensitive Areas TA-12-27-07, January 27, 2009 Edition. At least one copy of said text amendments shall be marked or stamped as "Official Copy as Adopted by Ordinance No. 8304" with all sections or portions thereof intended to be omitted clearly marked to show any such omission or showing the sections, articles, chapters, parts or portions that are incorporated, as the case may be, and to which shall be attached a copy of this ordinance, and filed with the City Clerk, to be open to inspection and available to the public at all reasonable business hours. The police department, municipal judge, and all administrative departments of the City charged with the enforcement of the ordinance shall be supplied, at the cost of the city, such number of official copies of such "Development Code of the City of Lawrence, Kansas Protection Standards for Environmentally Sensitive Areas TA-12-27-07, January 27, 2009 Edition" marked as may be deemed expedient.

SECTION III. Sections 20-701, 20-702, 20-1101, and 20-1701 of the Code of the City of Lawrence, Kansas, 2008 Edition, and amendments thereto, are hereby repealed it being the intent that the provisions of this ordinance supersede the repealed code provisions.

SECTION IV. If any section, clause, sentence, or phrase of this ordinance is found to be unconstitutional or is otherwise held invalid by any court of competent jurisdiction, it shall not affect the validity of any remaining parts of this ordinance.
