

**AGREEMENT**

This Agreement made as of the \_\_\_\_ day of February, 2009, by and between Unified School District No. 497, Douglas County, Kansas (herein "Lawrence Public Schools" or "LPS") and the City of Lawrence, Kansas (herein "the City").

RECITALS

1. On September 16, 2008, the City approved Special Use Permit 07-04-08 issued to LPS, subject to certain conditions, including Condition No. 11 requiring an operating agreement between the City and LPS regarding the maximum level of activity at the athletic fields.
2. The parties now desire to enter into an Agreement to satisfy said Condition No. 11.

It is agreed by the parties that permitted activities at the athletic fields under said Special Use Permit will be limited to LPS permitted, or directed, or sponsored activities, and as permitted under the Centennial Neighborhood Settlement Agreement dated January 15, 2009, until further agreement of the parties. In making this agreement it is understood that LPS cannot at all times reasonably limit and prevent the occasional use of the athletic fields by individuals who may come onto the school premises.
