ORDINANCE NO. 8693

AN ORDINANCE OF THE CITY OF LAWRENCE, KANSAS ENACTING CHAPTER 20, ARTICLE 10, SECTION 20-1011, AMENDING CHAPTER 20, ARTICLE 10, SECTIONS 20-1007 AND 20-1009 AND CHAPTER 20 ARTICLE 17, SECTION 20-1701, CODE OF THE CITY OF LAWRENCE, KANSAS, 2011 EDITION, AND AMENDMENTS THERETO, PERTAINING TO THE USE OF SYNTHETIC TURF AS A LANDSCAPE MATERIAL BY ADOPTING AND INCORPORATING HEREIN BY REFERENCE "LAND DEVELOPMENT CODE OF THE CITY OF LAWRENCE, KANSAS, TEXT AMENDMENTS, FEBRUARY 7, 2012 EDITION," AS PREPARED AND PUBLISHED BY THE LAWRENCE-DOUGLAS COUNTY METROPOLITAN PLANNING OFFICE OF THE CITY OF LAWRENCE, KANSAS, AND REPEALING EXISTING SECTIONS 20-1007, 20-1009 AND 20-1701.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LAWRENCE, KANSAS:

SECTION ONE: Chapter 20, "Land Development Code of the City of Lawrence, Kansas," Code of the City of Lawrence, Kansas, 2011 Edition, and amendments thereto, is amended as follows:

There is hereby adopted and incorporated herein by reference, as if fully set forth herein, for the purpose of enacting Chapter 20, Article 10, Section 20-1011 and amending Chapter 20, Article 10, Sections 20-1007 and 20-1009 and Chapter 20, Article 17, Section 20-1701, Code of the City of Lawrence, Kansas, 2011 Edition, and amendment thereto, "Land Development Code of the City of Lawrence, Kansas, Text Amendments, February 7, 2012 Edition," as prepared and published by the Lawrence-Douglas County Metropolitan Planning Office of the City of Lawrence, Kansas.

SECTION TWO: One copy of "Land Development Code of the City of Lawrence, Kansas, Text Amendments, February 7, 2012 Edition" shall be marked "Official Copy as Adopted by Ordinance No. 8693" and shall be filed, together with one copy of this ordinance, with the City Clerk. The City Clerk shall make the "Official Copy as Adopted by Ordinance No. 8693" open to the public and available for inspection at all reasonable office hours. One additional copy of the "Official Copy as Adopted by Ordinance No. 8693" shall, at the cost of the City of Lawrence, Kansas, be made available to the Lawrence-Douglas County Metropolitan Planning Office of the City of Lawrence, Kansas.

SECTION THREE: Existing sections 20-1007, 20-1009, and 20-1701, Code of the City of Lawrence, Kansas, 2011 Edition, and amendment thereto, are hereby repealed, it being the intent of the Governing Body that this ordinance, adopting and incorporating herein by reference "Land Development Code of the City of Lawrence, Kansas, Text Amendments, February 7, 2012 Edition," supersede the repealed code provisions.

SECTION THREE. If any section, clause, sentence, or phrase of this ordinance	is found	to be
unconstitutional or is otherwise held invalid by a court of competent jurisdiction, it	shall not	affect
the validity of any remaining parts of this ordinance.		

SECTION FOUR. This ordinance shall take effect and be in force from and after its passage and publication as provided by law.
