On behalf of my client, Bo Killough/12th & Haskell Recycling Center, this letter is to inform you that yesterday, May 10, 2012, my client purchased two properties, 1000 E. 11th Street and 1050 East 11th Street. On or before May 21, 2012 (the next submittal deadline), we will submit to you a minor subdivision, site plan(s), and special use permit which will allow Mr. Killough to move his operation from its current location to these properties. We intend to work with the City to have these items considered, and hopefully approved, as quickly as the City's processes will allow. Once the approvals are obtained, Mr. Killough will relocate his operation to these new properties as quickly as possible.

Because the timing of the relocation of the business is subject to the city's processes, we request that you stay the pending enforcement action for a reasonable time after the approvals are granted.
