**CHANGE ORDER NO. 4** 

This Change Order No. 4 covers adjustments to the Contract Time and Contract Price, which result from the changes in the work described herein. Included in this Change Order are Items CO4-1, initiated to re-coat the existing access hatches on Digester No. 1; CO4-2, initiated to relocate the pressure/vacuum relief valves; CO4-3, initiated to enclose the 10-inch digester gas pipe; CO4-4, initiated to remove and land spread additional sludge from digesters; CO4-5, initiated to update equipment tags to current standard tagging system; CO4-6, initiated to provide new sight glass windows on Digester Number 1; CO4-7, initiated to eliminate quarry tile flooring in the Gas Control Building; and CO4-8, initiated to add concrete floor sealer in the Gas Control Building.

<u>Item CO4-1. Re-coat the Existing Access Hatches on Digester No. 1.</u>

Initiated by: Owner/Engineer

This modification covers the removal of two (2) side access hatches, sandblasting the blind flanges and castings embedded in the concrete, coating the interior of the castings and blind flanges with coal tar epoxy, coating the exterior of the castings and blind flanges with epoxy and polyurethane, and replacing caulking along the joint between the side access hatches and the brick. This change results in an increase in Contract Price of \$10,864.00. This change represents an increase of fourteen (14) calendar days in Contract Time.

Item CO4-2. Relocate the Pressure/Vacuum Relief Valves.

Initiated by: Engineer/Owner

This modification covers the removal of the existing pressure/vacuum relief valves, adding additional piping and supports, and re-installing the pressure/vacuum relief valves on the roof of Digester No. 3 thus reducing explosion potential. This change results in an increase in Contract Price of \$15,570.00. This change represents an increase of zero (0) calendar days in Contract Time.

<u>Item CO4-3. Enclose the 10-Inch Digester Gas Pipe.</u>

Initiated by: Engineer/Owner

This modification covers the addition of light gage metal framing, densdeck boards, and roofing membranes to build an enclosure around the 10-inch gas pipe from Digester No. 3. This change is to facilitate installation of the roofing membrane with adequate encapsulation of penetrations to prevent leaks in the Sludge Control Building roof. This change results in an increase in Contract Price of \$3,205.00. This change represents an increase of zero (0) calendar days in Contract Time.

### Item CO4-4. Remove and Land Spread Additional Sludge from Digesters.

Initiated by: Owner/Engineer

This modification covers the removal and land spreading of additional sludge in Digesters No. 1 & 2. The actual volume of sludge in Digester Nos. 1 & 2 exceeded the estimated volumes in the Contract Documents, and this item covers the additional cost associated with the extra sludge volume that could not be removed. This change results in an increase in Contract Price of \$18,490.00. This change represents an increase of zero (0) calendar days in Contract Time.

### Item CO4-5. Update Equipment Tags to Current Standard Tagging System.

Initiated by: Owner/Engineer

This modification covers the removal of existing valve tags, and the installation of new tags conforming to the current standard tagging system, as well as the incremental cost to revise the new equipment and valve tags to the current standard tagging system. This change results in an increase in Contract Price of \$2,059.00. This change represents an increase of zero (0) calendar days in Contract Time.

### <u>Item CO4-6. Provide New Sight Glass Windows on Digester No. 1.</u>

Initiated by: Owner/Engineer

This modification covers the replacement of the six (6) existing sight glasses on Digester No. 1 with new sight glasses. This change results in an increase in Contract Price of \$994.00. This change represents an increase of zero (0) calendar days in Contract Time.

#### Item CO4-7. Eliminate Quarry Tile flooring in the Gas Control Building.

Initiated by: Owner/Engineer

This modification covers the elimination of quarry tile flooring in the Gas Control Building rooms 101 and 102. This change results in an decrease in Contract Price of (\$6,679.00). This change represents an increase of zero (0) calendar days in Contract Time.

### <u>Item CO4-8</u>. Add Concrete Floor Sealer in the Gas Control Building.

Initiated by: Owner/Engineer

This modification covers the addition of concrete floor sealer in the Gas Control Building rooms 101 and 102. This change results in an increase in Contract Price of \$928.00. This change represents an increase of zero (0) calendar days in Contract Time.
