Dear Mr. Walthall,


Yesterday I received a phone call from our landlord, Leroy Young, indicating that we needed to send in a Sign Permit Application for the painting we did in the alley on buildings located at 1109, 1111, and 1113 Massachusetts.

I have enclosed the permit as well as the \$25.00 fee for the painting. Had I known that this would be considered a sign I would have certainly submitted the paperwork for it.

Our landlord has been having difficulty with graffiti in this alleyway and has had to consistently (usually once a month) paint over it himself, hire someone else, or call the dept. of corrections to get it removed. We asked him, and received written permission, to cover the graffiti with paintings created by summer of service high school students in an effort to keep vandals from defacing his property. The 17 students worked in 102 degree heat to finish their project and did a wonderful job. Since this was a project in the alley, we had no idea that permission from any one else would be required.

I'm sorry for the misunderstanding.
