Re: Vermont Street parking garage and Lawrence Public Library site

Dear Dave:

We received bids on Tuesday, October 30, 2012 and subsequently have worked with BA Green to analyze bids and identify potential VE reductions to bring this bid package under budget. I have attached a list of detailed cost saving options that BA Green prepared.

In summary, we recommend approval to award the base bid contract in an amount of \$5,274,345 for the Vermont Street parking garage, Lawrence Public Library site construction, and general conditions for the entire project. This amount includes the following value engineering adjustments:

Base bid	\$5,149,489
Structural precast modifications (VE 1,4,10,11,13 & 14):	(\$177,234)
Delete/Modify special coatings on steel and metal panels, keep galvanizing: (VE 7 & 9)	(\$76,455)
Replace fence at interior light wall with cable barrier: (VE2)	(\$36,250)
Misc. specification changes: (VE 5,8 & 16)	(\$23,679)
Total reduction: Revised base bid with VE adjustments: General conditions:	(\$313,618) \$4,835,871 \$438,474
Total contract amount:	\$5,274,345

We will be working with the City and BA Green to develop a more definitive schedule and plan

over the next several weeks to identify how much parking we can have available by

Memorial Day. We anticipate being able to provide the first 2 decks accessible from Kentucky and

Vermont by Memorial Day. BA Green will provide a more detailed schedule, however it is

anticipated that construction of the utility work will start the week of December 17, 2012. The South

end of the parking lot will need to be closed the end of December in anticipation of work starting on

the garage.

We will receive bids from moving companies on November 20 with the intent of interviewing a

couple the first week in December in preparation for moving the Library out of the existing space

the first couple of weeks in January. Final documents for the library are anticipated to go out to bid

in mid- February.

In addition to our recommendation for the base bid, we received bids for Alternate No. 2 -

Additional parking deck. This was estimated at \$1,000,000, and the bids came in at \$834,806

including \$20,000 general conditions for BA Green. Based on that, we would recommend the city

approve the necessary steps to award this portion of the contract. BA Green has indicated that the

City can await a final decision on this alternate for 6 weeks (end of December) before a lack of

contract award for this portion of the project could start to effect production and schedule.
