1.0 **Purpose**

To prohibit concealed carry permit holders from carrying concealed handguns in or upon certain properties owned or occupied by the City, as authorized by the Kansas Personal and Family Protection Act and Ordinance 8048.

2.0 **Policy**

The following properties are hereby designated by the City Manager, under the authority of Ordinance 8048, as properties where the concealed carrying of handguns as authorized by the Kansas Personal and Family Protection Act is prohibited:

- A. The interior of all buildings and other structures owned by the City of Lawrence or open to the public and operated as business premises by the City of Lawrence. This list includes, but is not limited to the following properties located within the City of Lawrence.
