**Football Yard Parking Exemption Request – 808 Maine St**

Mayor and Commissioners,

The City Commission is considering whether it should amend the administrative policy permitting yard parking during home KU football games in designated zones and addresses. The specific application is to permit yard parking at 808 Main Street.

The Old West Lawrence Association recommends that the City Commission deny this request.

Old West Lawrence is neighborhood that has struggled to bring itself back from a deteriorating district with many properties that do not enhance the single-family character of the neighborhood. Our neighborhood accepts at great deal of traffic and congestion on game days and does not want these problems made any worse than they are. Use of the yard at 808 Maine Street for parking diminishes the value of the subject property, surrounding properties and the neighborhood as a whole.

*Recommendation*

The Old West Lawrence Association recommends that the City Commission deny the application of 808 Maine Street.
