David Ambler, chair, reported he sent the Director Evaluation and the Board Self-Assessment to the Board and asked that they complete them as quickly as possible and return to him to compile. David stated these will be discussed at the February Health Board meeting.

## DIRECTOR'S REPORT

- Dan Partridge updated the Board on a HIPAA breach investigation. After completing an internal investigation and consulting with legal counsel, it was determined that no breach occurred.
- 2. Dan Partridge reviewed the 2014 laboratory vendor report. Dan thanked Dr. Kevin Stuever for helping the Health Department keep lab testing local. Dan reported the Health Department is now doing Thin Prep PAP testing. Dan reported the Kansas Department of Health and Environment will continue to test Gonorrhea and Chlamydia, Syphilis, Herpes-culture, and Hepatitis C and that Lawrence Memorial Hospital will test for Thin Prep PAP, HIV and HPV.

- 3. Dan Partridge presented an overview of Board Talking Points and asked for comments. Suggestions from the Board are to put in contact information, work on an opening statement that includes everyone not just young people and those employed. Need to put in specifics of what we are doing to address issues listed. Revise "Changing the way we work with you" to "Strengthening the way we work with you." Also, under History, state how old the Health Department is.
- 4. Dan Partridge reported the Health Department will be closed on Friday, February 7, 2014, for staff training on motivational interview which will benefit all staff.
  - Dan also stated the week of April 7-13, 2014, is National Public Health Week. The Kay Kent Excellence in Public Health Service Award and staff luncheon will be Tuesday, April 8, 2014, from noon to 1 p.m.
- 5. Chair David Ambler tabled the Executive Session for the purpose of discussing personnel matters related to the annual evaluation of the Director to the February Board meeting.

1. The next scheduled Health Board meeting will be held on Monday, February 17, 2014, at 5 p.m. in the first floor meeting room.
