The City of Lawrence requests funding to repair Taxiway C. The pavement estimate
is 5" of asphalt on 6" of rock base.
Total Project Costs \$180,000
We understand that if the project is approved, the Kansas Department of Transportation will participate in the project cost at the rate identified in the Program Guidelines as published on the KDOT Aviation website ( <a href="http://www.ksdot.org/divAviation">http://www.ksdot.org/divAviation</a> ), not to exceed \$800,000 of state funds (\$1,600,000 for new primary runways; \$1,200,000 for full-depth reconstruction of existing primary runway). The Sponsor will be responsible for letting the contract for bids and supervising construction. Construction engineering is an eligible cost on construction contracts. Design is not an eligible cost except through a separate design grant.
