RE: 2014 Annual Street Event Report and Direction from the Commission of what type of events they want on agendas.

In 2014 the Public Works Department took over the overall management of the street event permits process. During this year the department implemented many positive changes to the process.

- Simplification of the permit application form
- Centralized permit issuing process "one stop shop"
- Creation of an event coordination and review team
- Updated the web site
- Simplified the no parking signage and meter bag process

This also included coordination, planning and notification to affected residents and businesses.

2014 proved to be a very busy year for street event permit applications. In total the Public Works Department issued 56 permits. The chart(s) below summarizes the events.

In an effort to better streamline this process we are continuing to work on various aspects of the process. We held the first annual street event stakeholders meeting on January 14, 2015. Each event applicant was invited to an open discussion about the event permit process. We had a great turn out and the discussion will help us to better manage the street event application process. In addition, many of the attendees agreed to be on process committees to help us define the process.

As part of that discussion we would also like direction from the Commission on what type of events they wish to see on commission agendas for their consideration. Currently almost all downtown events are placed on the commission agenda for review and commission action. Many of these events include street closures for one to multiple days, other only have temporary or rolling closures of streets (mostly associated with walks and 5K runs and usually last less than 30 minutes). There are events that do not impact streets at all.

ACTION
