

Subject:	2015 Sales Tax Distributions

The City of Lawrence has recently received its May sales tax and its share of County sales tax distribution. The distribution is the result of retail sales from mid-February to mid-March. The distribution of \$2,884,910 is \$33,016 less than the prior year distribution for the same month. It also includes \$9,260 from the Free State Transportation Development District (TDD), \$12,882 from the Oread TDD and \$306 for the 9th & New Hampshire TDD. The distribution also includes other amounts that will be paid to the Oread Tax Increment Financing District.



Based on the last several months of collections we are now estimating a total increase of sales and use tax of 5% for the 2015 budget year. The following graph shows the history of total sales and uses tax by year and a total \$25.9 million projected in 2015 for total sales and use tax.



On a month-to-month basis, we saw a large increase in February 2015 receipts over 2014. This reflects what we would typically see in taxable sales for mid-November to mid-December. However, this past holiday season was much higher than the previous year. The March and April collections are in the typical range for this time of year. Although June collections dropped slightly, we are still seeing a 5.3% increase over last year. At this time we are using the latest sales tax figures to increase our 2015 revenue estimate to 5% over actual 2014 collections.
