# PROJECT FACT SHEET MUNICIPAL SERVICES & OPERATIONS – LAWRENCE, KS

## **PROJECT DESCRIPTION**

The City is beginning work on a 2025 Street Maintenance project in your area which may impact your property, business, or residence. The project includes the following work location(s) (see the attached map for location and type of work reference):

- Sherwood Dr Kasold Dr to 275' East of Regents St.
- Regents St Sherwood Dr to 175' South of Sherwood Dr.
- Sherwood Ct Sherwood Dr to Cul-de-sac.
- Sterling Dr Sherwood Dr to Peterson Rd.

Businesses and residents will be notified a minimum of 48 hours in advance of any access restrictions to their property.

#### PROJECT TIME FRAME

The City anticipates the following construction schedule timeline, which is shown below. These dates are subject to change due to weather or other construction-related delays.

## **PROJECT RESPONSIBILITIES**

The contractor is responsible for traffic control, cleaning up the worksite every night, maintaining access during construction, and barricading open excavation areas. You can help prevent accidents by following the traffic control signs in the area during construction and staying away from the worksite.

### **RIGHT OF WAY RESPONSIBILITIES**

The contractor is responsible for the restoration of the project area after completion, including seed, fertilizer, and straw. Per City Code 16-803, the City will not compensate property owners for damage to plants, trees, sprinklers, or other private improvements in the Public Rights-of-Way as the result of any construction activities.

## ANTICIPATED TRAFFIC ROUTING IMPACTS

Work will be completed within the public right-of-way and utility easements. During construction, traffic impacts will be limited to locations where the contractor is working. Local traffic will be maintained at all times.

Over the course of the project, there will be temporary traffic restrictions at various locations along the length of the project. Construction activities and associated traffic control will be sequenced to minimize disruption and will not all be performed at one time.

It is our intent to maintain access to your business or residence from at least one direction at all times during construction. Access to individual driveways and parking spots may be restricted during the working day while work is being completed directly adjacent to a driveway.
